

**RESOLUTION NO. 2019-**  
**RESOLUTION OF THE CITY COUNCIL**  
**OF THE CITY OF ROCKLIN**  
**SETTING A PUBLIC HEARING ON**  
**DELINQUENT REFUSE COLLECTION CHARGES**

WHEREAS, the City Council of the City of Rocklin has awarded to Recology Auburn Placer a franchise for the collection of solid waste within the City of Rocklin under Rocklin Municipal Code Chapter 13.08; pursuant to California Government Code sections 25831 and 38790.1; and

WHEREAS, under the terms of the franchise agreement, the City may at the request of Recology Auburn Placer, assist in collecting delinquent garbage bills in accordance with Government Code sections 25831 and 38790.1;

WHEREAS, Recology Auburn Placer has requested the City to conduct proceedings under Government Code sections 25831 and 38790.1 to place liens against those properties delinquent in their solid waste collection fees; and

WHEREAS, the City Council has determined to grant the request;

The City Council of the City of Rocklin does resolve as follows:

Section 1. The City Manager is directed to prepare and submit to the City Council a Report of Delinquent Fees pursuant to Government Code section 25831, to include Recology Auburn Placer collection charges against the owner of parcels located in the City of Rocklin that have remained unpaid for at least 180 days, said Report to include identification of the property and an itemized record of the delinquent charge.

Section 2. The City Council hereby sets a public hearing to be held on May 28, 2019, at the Rocklin City Hall building, located at 3970 Rocklin Road, at 6:00 P.M. or as soon thereafter as the matter may be heard, to consider the Report of Delinquent Fees and the imposition of liens on certain parcels of property within the City of Rocklin because of delinquent refuse collection charges for parcels that have remained unpaid for at least 180 days.

Section 3. Notice of the hearing shall be mailed to each affected owner of record as shown on the report by certified, return receipt mail to the address of the owners as shown on the last equalized assessment roll of the County of Placer or as otherwise known to the City at least ten (10) days prior to the hearing.

Section 4. Any interested person may appear at the hearing and protest the delinquent charges.

Section 5. The City Council may, after the hearing, and after considering any objections or protests of landowners liable to be liened for delinquent fees, revise or correct the Report of Delinquent Fees, or confirm the Report by resolution, and establish a lien on the property tax roll on those properties for which services were rendered to the owner thereof for collection of refuse plus City and County lien processing fees.

Section 6. Notice of the Public Hearing shall be posted in one public place within the City and published once in the Placer Herald, a newspaper of general circulation circulated in the City of Rocklin, not less than ten (10) days before the hearing.
