RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF ROCKLIN
ESTABLISHING THE APPROPRIATION LIMITATION
OF THE SPECIAL TAX DISTRICTS FOR FISCAL YEAR 2019-20
AND AMENDING THE
APPROPRIATION LIMITATION FOR FISCAL YEAR 2018-19

The City Council of the City of Rocklin does resolve as follows:

WHEREAS, Article XIII B of the Constitution of the State of California provides that the total annual appropriations subject to limitation of the State and of each local government shall not exceed the appropriations limit of such entity of government for the prior year adjusted for changes in the cost of living and population except as otherwise provided in said Article XIII B; and

WHEREAS, pursuant to said Article XIII B of the Constitution of the State of California, and Section 7910 of the California Government Code, which implements Article XIII B, the City is required to establish its appropriations limit for each fiscal year; and

WHEREAS, the documentation used in the determination of the City's appropriations limit has been made available to the public for fifteen days prior to the date of adoption of this resolution as required by Government Code section 7910.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Rocklin as follows:

Section 1. The estimated actual appropriations for the Community Facilities District No. 1 for fiscal year 2018-19 are \$1,650,000 and will not exceed the \$7,971,751 appropriation limitation as amended for the 2018-19 fiscal year.

Section 2. The appropriation limitation for the Community Facilities District No. 1 for fiscal year 2019-20 is established to be \$8,593,547, as documented in Exhibit A attached hereto.

Section 3. The estimated actual appropriations for the Community Facilities District No. 5 for fiscal year 2018-19 are \$4,343,000 and will not exceed the \$48,324,068 appropriation limitation as amended for the 2018-19 fiscal year.

Section 4. The appropriation limitation for the Community Facilities District No. 5 for fiscal year 2019-20 is established to be \$52,093,345, as documented in Exhibit A attached hereto.

Section 5. The estimated actual appropriations for the Community Facilities District No. 6 for fiscal year 2018-19 are \$300,000 and will not exceed the \$5,975,196 appropriation limitation as amended for the 2018-19 fiscal year.

Section 6. The appropriation limitation for the Community Facilities District No. 6 for fiscal year 2019-20 is established to be \$6,441,261, as documented in Exhibit A attached hereto.

Section 7. The compound factor used in calculating the 2019-20 appropriation limitation was 1.0780, which represents the annual change in City population and California per capita income.
