**Project Title:** Stormwater Pipe Replacement Project

**Project Location - Specific:** The proposed project location is existing roadways and easeemnts within the City of Rocklin.

Project Location - City: Rocklin, CA; County: Placer

**Description of Nature, Purpose and Beneficiaries of Project:** The project involves rehabilitating storm water runoff drainage pipelines within existing drainage easements or City right-of-way throughout the City of Rocklin. The rehabilitation method(s) will be determined on a case by case basis and will include the use of cure in place products, sleeve products and/or total removal and replacement. All the work would occur within existing drainage easements or City right-of-way and there would be no or negligible expansion or increase in the capacity of the drainage pipelines.

Reasons why the project is exempt. The project involves rehabilitating storm water runoff drainage pipelines as further described above. Class 1 exemptions consist of the minor alteration of existing facilities involving negligible or no expansion beyond the existing use. Examples include but are not limited to: (b) Existing facilities of both investor and publicly owned utilities used to provide electric power, natural gas, sewerage, or other public utility services, and (d) Restoration or rehabilitation of deteriorated or damaged structures, facilities or mechanical equipment to meet current standards of public health and safety, unless it is determined that the damage was substantial and resulted from an environmental hazard such as earthquake, landslide, or flood. Class 2 exemptions consist of replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced, including but not limited to: (c) replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity. The project as proposed is consistent with the exemption class descriptions noted above and is exempt pursuant to Classes 1 and 2 of the CEQA Guidelines.
