RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN APPROVING THE ADOPTION OF
THE 2020-2024 CONSOLIDATED PLAN AND
2020-2021 ONE-YEAR ACTION PLAN
AND AUTHORIZING THE CITY MANAGER TO EXECUTE
AND FILE ALL DOCUMENTS REQUIRED TO RECEIVE
U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) COMMUNITY
DEVELOPMENT BLOCK GRANT (CDBG) FUNDING

WHEREAS, the Community Development Block Grant Program, authorized pursuant to Title 1 of the Housing and Community Development Act of 1974, as amended (Act), requires that jurisdictions provide for the issuance of grants in order to attain the objective of providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low- and moderate-income; and

WHEREAS, there has been presented to, and reviewed by this City Council, the 2020-2024 Consolidated Plan, which outlines needs, priorities, market conditions, and strategies to utilize funds in a way that addresses needs identified, and the 2020-2021 Action Plan, which describes programs to be funded, in compliance with the goals and objectives of the Consolidated Plan, for the 2020-2021 program year; and

WHEREAS, the City has prepared an application on Standard Form 424 (Application) to HUD for a Community Development Block Grant in the amount of \$279,106.00, for the period of July 1, 2020 through June 30, 2021; and

WHEREAS, the City is required to submit certifications to the U. S. Department of Housing and Urban Development (HUD), including those regarding affirmatively furthering fair housing, anti-displacement and relocation plan, drug free workplace, anti-lobbying, authority of jurisdiction, consistency with strategic plan, citizen participation, community development plan, following Consolidated Plan, use of funds, prohibition of excessive force, compliance with anti-discrimination laws, and lead-based paint; and

WHEREAS, the Consolidated Plan, the Action Plan, and a notice of the 30-day public comment period, have been published for citizen comment prior to forwarding the documents to City Council for approval;

NOW THEREFORE, the City Council of the City of Rocklin does resolve as follows:

<u>Section 1.</u> The City Council of the City of Rocklin hereby approves the adoption of the City of Rocklin 2020-2024 Consolidated Plan and the 2020-2021 Action Plan in substantially the form attached hereto as Exhibit A and by this reference incorporated herein, certifying that the City of Rocklin has and will continue to conduct its activities in accordance with applicable

statutes and regulations governing the CDBG Program, as identified in the accompanying Certifications in the form attached hereto as Exhibit C and by this reference incorporated herein.

Section 2. The City Council of the City of Rocklin hereby approves and authorizes the City Manager, or his designee, to execute the Grant Agreement and file the Application (SF 424) in substantially the form attached hereto as Exhibit B and by this reference incorporated herein, the Action Plan and Certifications, including all documents that are required to receive CDBG funding for and on behalf of the City of Rocklin.
