**RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF ROCKLIN
ORDERING THE PREPARATION OF THE ENGINEER'S REPORT FOR
LIGHTING MAINTENANCE DISTRICT NO. 1**

The City Council of the City of Rocklin does resolve as follows:

WHEREAS, pursuant to the California Streets and Highways Code Part 2, Section 22500 et seq. known as the "Landscaping and Lighting Act of 1972" ("Act"), the City Council of the City of Rocklin has formed a maintenance district that is known and designated as: LIGHTING MAINTENANCE DISTRICT NO. 1 (hereinafter referred to as the "Maintenance District"); and

WHEREAS, the City Council of the City of Rocklin desires to initiate proceedings for the annual levy of the assessments as required following the formation of the Maintenance District; and

WHEREAS, these proceedings for the annual levy of assessments shall relate to the fiscal year commencing July 1, 2020 and ending June 30, 2021; and

WHEREAS, a map showing the boundaries of the area affected by the annual levy of assessment for fiscal year 2020-2021, is attached hereto as Exhibit "A"; and

WHEREAS, no new improvements or substantial changes to existing improvements are proposed; and

WHEREAS, the Act requires a written report prepared by an engineer consisting of the following:

1. Plans and specifications of the improvements.
2. An estimate of the costs of the improvements for the fiscal year.
3. A diagram for the assessment district.
4. An assessment of the estimated cost of the improvements for the fiscal year.
5. If bonds or notes will be issued, an estimate of their principal amount.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

Section 1. The above recitals are all true and correct.

Section 2 A map entitled "Lighting Maintenance District No.1" showing the boundaries of the area to be assessed is hereby approved and adopted, and a copy shall be on file in the office of the City Clerk and open for public inspection. The parcels and properties within said area are those to be assessed to pay certain of the costs and expenses for maintenance work in the District.

Section 3. The proposed maintenance work within the area to be assessed shall be for certain street lighting and traffic signalization improvements, as said maintenance work shall be set forth in the Engineer's Report to be prepared for this City Council for consideration.

Section 4. It is ordered that an Engineer's Report be prepared relating to said annual assessment and levy in accordance with the provisions of California Streets and Highways Code commencing with Section 22565.

Section 5. Upon completion, the Engineer's Report shall be filed with the City Clerk who shall then submit the same to the City Council for its consideration pursuant to Streets and Highways Code Sections 22623 and 22624.
