RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN ORDERING THE PREPARATION OF THE ENGINEER'S REPORT FOR LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT NO. 2

The City Council of the City of Rocklin does resolve as follows:

WHEREAS, pursuant to the California Streets and Highways Code Division Part 2, Section 22500 et seq. known as the "Landscaping and Lighting Act of 1972" ("Act"), the City Council of the City of Rocklin has formed a maintenance district that is known and designated as: LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT NO. 2 (hereinafter referred to as the "Maintenance District"); and

WHEREAS, the City Council of the City of Rocklin desires to initiate proceedings for the annual levy of the assessments as required following the formation of the Maintenance District; and

WHEREAS, these proceedings for the annual levy of assessments shall relate to the fiscal year commencing July 1, 2020 and ending June 30, 2021; and

WHEREAS, a map showing the boundaries of the area affected by the annual levy of the assessment for the above-referenced fiscal year is attached hereto as Exhibit "A"; and

WHEREAS, no new improvements or substantial changes to existing improvements are proposed; and

WHEREAS, the Act requires a written report consisting of the following:

- 1. Plans and specifications of the improvements;
- 2. An estimate of the costs for improvements for the fiscal year;
- 3. A diagram for the assessment district;
- 4. An assessment of the estimated costs for the fiscal year; and
- 5. If bonds or notes will be issued, an estimate of their principal amount.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

Section 1. The above recitals are all true and correct.

Section 2. A map entitled "Landscape and Lighting Maintenance District No. 2" showing the boundaries of the area to be assessed is hereby approved and adopted by this City Council, and a copy shall be on file in the office of the City Clerk and open for

public inspection. The parcels and properties within said area are those to be assessed to pay certain costs and expenses for said maintenance work.


<u>Section 3.</u> The proposed maintenance work within the area to be assessed shall be for certain street lighting improvements and landscape maintenance, as said maintenance work shall be set in the Engineer's Report to be prepared for the City Council for consideration.

<u>Section 4.</u> An Engineer's Report is ordered to be prepared relating to said annual assessment and levy in accordance with the provisions of California Streets and Highways Code commencing with Section 22565.

<u>Section 5.</u> Upon completion of the Engineer's Report, it shall be filed with the City Clerk who shall then submit the same to the City Council for its consideration pursuant to Streets and Highways Code Sections 22623 and 22624.
