RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF ROCKLIN ACCEPTING THE PUBLIC WORK KNOWN
AS RANCH VIEW DRIVE ROAD RESURFACING PROJECT, APPROVING THE NOTICE OF
COMPLETION THEREOF, AND AUTHORIZING THE EXECUTION AND RECORDATION OF SAID
NOTICE ON BEHALF OF THE CITY

WHEREAS, on March 10, 2020, Council adopted Resolution 2020-44, awarding the contract for the Ranch View Drive Road Resurfacing Project to American Pavement System, Inc.; and

WHEREAS, all work associated with this project was completed on May 18, 2020; and

WHEREAS, a project cost of \$187,560 is included in the FY 19-20 budget for Ranch View Drive Road Resurfacing and no additional appropriation is needed; and

WHEREAS, the total project cost for Ranch View Drive Road Resurfacing came in under budget at \$160,364; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

Section 1. The attached Notice of Completion relative to that public work known as Ranch View Drive Road Resurfacing Project is hereby approved and the public work accepted.

Section 2. The Director of Public Services is authorized to execute said Notice on behalf of the City of Rocklin.

Section 3. The City Clerk is authorized to record said Notice in the Office of the Placer County Recorder when fully executed and notarized and within ten (10) days of Council approval.
