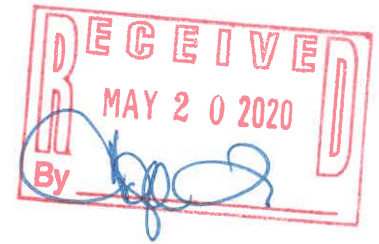

re: Proposed Recology Rate Increase

Dear Hope,

Thank you for the informative phone conversation at the end of May. I appreciate that your office was open and you were available during these uncertain times.

I am writing to protest the Recology rate increase that will be discussed at the upcoming City Council meeting on June 23, 2020. Due to the uncertain conditions of being in a public place at this time, I am choosing to write to you rather than attend the City Council meeting in person. I understand that you will submit this letter of protest at the City Council meeting.

I have the following points to be heard at the City Council meeting and wish them to be considered during discussion of the proposed rate increase:

- 1) I understand that if the rate increase is approved, that my residential rate will increase by \$1.14 a month. I understand that this increase will help cover a cost of living increase and a landfill rate increase. I **do not** want to be responsible to cover the cost of living increase for the employees of the Recology company. Cost of living increases should be covered by Recology without an impact in their customers.
- 2) I want to express my concern for those of us on fixed incomes. Every year we face increased costs for services we require, but we don't get an increase in our income to balance out the higher costs of these services. Every cent counts and this is why I am protesting this rate increase, seeing my fixed income stretched even further. I **do not** want a higher monthly bill to support Recology employees cost of living increase. This is a burden for those of us on fixed incomes.

Mr. Mayor Greg Janda, Vice-Mayor Jill Gayaldo, and council members Ken Broadway, Bill Halldin and Joe Patterson, I appreciate your consideration of these points during the City Council meeting. I look forward to listening to the meeting via the online portal.
