RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN  
ACCEPTING THE PUBLIC WORK KNOWN AS STORMWATER PIPE REPLACEMENT,

(SAK Construction, LLC)

WHEREAS, on February 11, 2020, the City Council approved Resolution 2020-24, awarding the contract for the Stormwater Pipe Replacement Project to SAK Construction, LLC; and

WHEREAS, all work associated with this project was completed on June 18, 2020;  
and

WHEREAS, the total cost for Stormwater Pipe Replacement area was \$150,000;  
and

WHEREAS, the cost of \$150,000 was included in the FY 19-20 budget for the Stormwater Pipe Replacement and no additional appropriation is needed; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

Section 1. The attached Notice of Completion relative to that public work known as Stormwater Pipe Replacement Project (SAK Construction, LLC), is hereby approved and the public work accepted.

Section 2. The Public Services Director is authorized execute said Notice on behalf of the City of Rocklin.

Section 3. The City Clerk is authorized to record said Notice in the Office of the Placer County Recorder when fully executed and notarized and within ten (10) days of Council approval.
