RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN
AWARDING THE CONTRACT FOR THE DESIGN AND CONSTRUCTION ENGINEERING SERVICES
FOR THE PAVEMENT REHABILITATION PROJECT, AUTHORIZING THE CITY MANAGER TO
EXECUTE AN AGREEMENT WITH R. E. Y. ENGINEERS, INC.,
AND AUTHORIZING ADDITIONAL APPROPRIATIONS

WHEREAS, the Pavement Rehabilitation Project, also known as Citywide Digouts, consists of projects that use Federal funds from the Regional Surface Transportation Program (RSTP) which are administered through the Placer County Transportation Planning Agency (PCTPA); and

WHEREAS, these funds are used for arterial and collector road repairs and maintenance in order to preserve the roadways and extend the life of the roadways; and

WHEREAS, PCTPA has indicated that project construction funding may become available prior to the FY 23-24 year perhaps as soon as FY 21-22 which will require that the design phase of this project be completed in FY 20-21 to be eligible for advanced funding; and

WHEREAS, the City issued a Request for Proposal for design and construction engineering on November 6, 2020, with a submittal date of December 9, 2020; and

WHEREAS, staff received four submittals, evaluated the proposals, and determined R.E.Y. Engineers, Inc. provided the proposal that was most advantageous to the City, with a negotiated contract amount of \$124,500; and

WHEREAS, this project will be funded with RSTP funds (240) for a total of \$124,500, which was not budgeted in FY 20-21, and therefore, a budget appropriation is necessary at this time.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

Section 1. The contract for design and construction engineering services for the Pavement Rehabilitation Project is awarded to R.E.Y. Engineers Inc., and the City Manager is authorized to execute an Agreement with R.E.Y. Engineers Inc. in substantially the form attached hereto as Exhibit "A."

Section 2. An additional capital appropriation in the amount of \$124,500 for the FY 20-21 Budget is authorized as follows:
