RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF ROCKLIN AUTHORIZING THE USE OF PROJECT FUNDS FOR FOOD SERVICES,  
AND OTHER MISCELLANEOUS EXPENSES, AUTHORIZING ACCEPTANCE OF  
THE BONSAI DESIGN GMP AND THE ADDITION OF A KING SWING, APPROVING THE  
ALLOCATION OF ADDITIONAL FUNDS TO COMPLETE THE ADVENTURE PARK, AND  
DIRECTING THE SOLICITATION OF BIDS TO ADD A DECK

WHEREAS, the City Council of the City of Rocklin has reviewed the status of the Adventure Park construction project and wishes to grant the City Manager authority to expend up to \$486,898 from budgeted project funds to install a food services building and purchase necessary food service equipment; and

WHEREAS, the City Council of the City of Rocklin wishes to authorize the City Manager to expend up to \$215,000 from budgeted project funds for miscellaneous expenses to complete the food service and restroom components of the adventure park; and

WHEREAS, Bonsai Design has indicated a guaranteed maximum price of \$3,038,000 (GMP) to complete the adventure elements under the current contract, and has proposed an additional \$410,000 to include the King Swing element in the project; and

WHEREAS, the City Council of the City of Rocklin wishes to authorize the City Manager to negotiate and execute changes orders with Bonsai Design to (1) accept the GMP of \$3,038,000 for the existing Adventure Park elements; and (2) to add construction of a King Swing element for \$410,000, with a 15% contingency of \$61,500, for a total of \$471,500; and

WHEREAS, the City Council of the City of Rocklin wishes to include an outdoor deck in the Adventure Park project, subject to the solicitation of bids and the awarding of a bid for this element of the project; and

WHEREAS, the City Council of the City of Rocklin has determined that an additional \$150,000 in funds is necessary to complete the adventure park project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

Section 1. The City Council authorizes the City Manager to take any action necessary, including execution of contract(s), to purchase and install the food service components of the project, including the purchase of food service equipment, for up to \$486,898 from budgeted project funds.

Section 2. The City Council authorizes the City Manager to expend up to \$215,000 of budgeted project funds for the completion of food service, restroom, and miscellaneous components of the project;

Section 3. The City Council authorizes the City Manager to negotiate and execute change order(s) with Bonsai Design to accept the GMP of \$3,038,000 and to construct a King Swing element for \$410,000, plus a 15% contingency amount of \$61,500, for a total of \$471,500.

Section 4. The City Council directs staff to solicit bids to construct an outdoor deck.

Section 5. The City Council approves an additional budget allocation of \$150,000 to complete the adventure park elements described herein.
