## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN OF INTENT TO AMEND THE SOLID WASTE COLLECTION SERVICE RATES WITHIN THE INCORPORATED LIMITS OF THE CITY OF ROCKLIN AND SETTING A PUBLIC HEARING THEREON

WHEREAS, Recology Auburn Placer is the franchise solid waste disposal contractor for the City of Rocklin; and

WHEREAS, Recology Auburn Placer has approached the City with a request for a Cost of Living Adjustment rate adjustment as provided by the terms of the Franchise Agreement for Solid Waste Handling Services between the City of Rocklin and Recology Auburn Placer; and

WHEREAS, with the passage of legislation Senate Bill (SB) 1383 current landfill costs will increase to prepare for the additional SB1383 requirements effective January, 1, 2022, and to operate a high efficiency material recovery facility; and

WHEREAS, Rocklin Municipal Code Section 13.08.100 provides that fees for collection of solid waste shall be set by resolution of the City Council.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

<u>Section 1</u>. The above recitals are all true and correct.

<u>Section 2</u>. The cost of living service rate increase and Landfill cost increase presented and requested by Recology Auburn Placer, the City of Rocklin's franchised solid waste hauler, is shown in the attached Exhibit "A," which is incorporated herein by this reference.

Section 3. Notice is hereby given that Tuesday, June 22, 2021, at 6:00 p.m. or as soon thereafter as the matter may be heard in the Council Chambers of the City of Rocklin, 3970 Rocklin Road, Rocklin, California, the City Council shall hold a public hearing to provide an opportunity for owners of property and customers served by Recology Auburn Placer to appear and protest the proposed increase in fees. In the alternative, owners of property and customers served by Recology Auburn Placer may file a written protest with the City Clerk at the above address. The written protest must identify the parcel served by address or APN (assessor's parcel number) and be actually received (not postmarked) by the City Clerk, before or during the public hearing. Only one protest per parcel shall be counted for purposes of establishing a majority protest to the proposed fee increase.

<u>Section 4</u>. The City Clerk is authorized and directed to give further or additional notice of the proposed service rate increase and the time and place of the above noted Public Hearing, in the time, form and manner required by law.

<u>Section 5</u>. For any and all information relating to the proceedings, protest procedure, any documentation and/or information of a procedural or technical nature, your attention is directed to the below listed person and the local agency or department so designated:
