RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN REQUESTING THE COLLECTION OF SPECIAL TAXES ON THE 2021-22 TAX ROLL

WHEREAS, the County of Placer requires, as a condition of the collection of taxes, assessments, liens and other charges on behalf of the City that the City warrant the legality of said charges and defend and indemnify the County from any challenge to the legality thereof.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

<u>Section 1</u>. The Auditor-Controller of Placer County is requested to attach for collection on the County 2021-22 tax rolls the following:

- a. City of Rocklin Community Facility District No. 1 special taxes ("Taxes") as set forth in Rocklin City Council Resolution No. 86-102 and Ordinance No. 802;
- b. City of Rocklin Community Facility District No. 5 special taxes ("Taxes") as set forth in Resolution No. 96-255 and Ordinance No. 805;
- c. City of Rocklin Community Facility District No. 6 special taxes ("Taxes") as set forth in Resolution No. 98-286 and Ordinance No. 792;
- d. City of Rocklin Community Facility District No. 7 special taxes ("Taxes") as set forth in Resolution No. 97-255 and Ordinance No. 768;
- e. City of Rocklin Community Facility District No. 8 special taxes ("Taxes") as set forth in Resolution No. 98-290 and Ordinance No. 793;
- f. City of Rocklin Community Facility District No. 9 special taxes ("Taxes") as set forth in Resolution No. 98-315 and Ordinance No. 796;
- g. City of Rocklin Community Facility District No. 10 special taxes ("Taxes") as set forth in Resolution No. 2005-81 and Ordinance No. 895;
- h. City of Rocklin Community Facility District No. 11 special taxes ("Taxes") as set forth in Rocklin City Council Resolution No. 2006-299;
- City of Rocklin Park Development and Maintenance Taxes as set forth in Rocklin City Council Resolution No. 2018-298, Resolution No. 2009-186, Resolution No. 98-172, and Ordinance No. 7.

<u>Section 2</u>. The City warrants and represents that the Taxes comply with all requirements of state law, including, but not limited to, Articles XIIIC and XIIID of the California Constitution (Proposition 218).

<u>Section 3</u>. The City releases and discharges County, and its officers, agents and employees from any and all claims, demands, liabilities, costs and expenses, damages, causes of action, and judgments in any manner arising out of the collection by County of any of the Taxes on behalf of City.

<u>Section 4</u>. The City agrees to and shall defend, indemnify, and hold harmless the County, its officers, agents, and employees (the "Indemnified Parties") from any and all claims, demands, liabilities, costs and expenses, damages, causes of action, and judgments in any manner arising out of the collection by County of any of the Taxes requested to be collected by County for City, or in any manner arising out of City establishment and imposition of said Taxes. City agrees that, in the event a judgment is entered in a court of law against any of the Indemnified Parties as a result of the collection of one of the Taxes, the County may offset the amount of the judgment from any other monies collected by the County on behalf of the City, including property taxes.

<u>Section 5</u>. The City agrees that its officers, agents and employees will cooperate with the County in answering questions referred to City by County from any person concerning the City's taxes, and that City will not refer such persons to County officers and employees for response.

<u>Section 6</u>. The City agrees to pay such reasonable and ordinary charges as the County may prescribe to recoup its costs in placing on the tax rolls and collecting the taxes, as provided by Government Code sections 29304 and 51800.
