RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN  
AWARDING THE CONTRACT FOR THE CITY OF ROCKLIN ANNUAL DIG OUTS PROJECT TO  
CENTRAL VALLEY ENGINEERING AND ASPHALT, INC. AND AUTHORIZING THE CITY  
MANAGER TO EXECUTE AN AGREEMENT WITH CENTRAL VALLEY ENGINEERING AND  
ASPHALT, INC.

WHEREAS, the City of Rocklin Annual Dig Outs Project provides a competitive price for removal and replacement of degraded asphalt on various roadways within the City of Rocklin; and

WHEREAS, the invitation for bids on the Project was advertised on May 28, 2021, and June 4, 2021, with bids opened on June 16, 2021, examined, and found to be in compliance with all applicable specifications; and

WHEREAS, four bids were received with the lowest bid amount of \$828,575 submitted by Central Valley Engineering and Asphalt, Inc., and staff recommend awarding the contract for the Annual Dig Outs Project to Central Valley Engineering and Asphalt Inc.; and

WHEREAS, other City divisions/departments will be allowed use the contract and there is no additional fiscal impact as the divisions/departments will use previously approved budgeted amounts to cover associated costs with this contract; and

WHEREAS, the contract will be for an initial eleven (11) month term and is renewable on a year to year basis for two (2) additional one-year terms at the City's option; and

WHEREAS, should the contract be renewed by the City, the unit pricing may not be increased by more than three percent for each year the contract is renewed.

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

Section 1. The City Council awards the contract for the City of Rocklin Annual Dig Outs Project to Central Valley Engineering and Asphalt, Inc. in an amount of \$828,575.

Section 2. The City Manager is authorized to execute an Agreement with Central Valley Engineering and Asphalt Inc. for the Annual Dig Outs Project in substantially the form attached hereto as Exhibit "A."

Section 3. To the extent funds are allocated for the Project in future years, the City Manager is authorized to renew the Agreement with Central Valley Engineering and Asphalt Inc. for two (2) additional one-year periods under the same terms, except that the unit pricing may be increased by no more than three percent each year.
