## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN AWARDING THE CONTRACT FOR THE CITY OF ROCKLIN STRIPING AND MARKING MAINTENANCE SERVICES 2021/22 PROJECT TO SIERRA TRAFFIC MARKINGS, INC. AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH SIERRA TRAFFIC MARKINGS, INC.

WHEREAS, the City of Rocklin Striping and Marking Services provides a competitive price for striping and marking services that can be used on multiple projects that are part of the Fiscal Year (FY) 2021/22 budget and 2022-2026 Capital Improvement Plan; and

WHEREAS, the invitation for bids on the Project was advertised on May 28, 2021, and June 4, 2021, the bid was opened on June 16, 2021, at 1:00 P.M., examined, and found to be in compliance with all applicable specifications; and

WHEREAS, this contract enables other City divisions/departments to utilize this contract and is for an initial eleven (11) month term, and is renewable on a year to year basis for up to two (2) additional one-year terms at the City's option; and

WHEREAS, the bid package consisted of a bid schedule (unit pricing) with a quantity identified for bidding purposes, and one (1) bid was received with a bid amount of \$174,860 that was submitted by Sierra Traffic Markings, Inc.; and

WHEREAS, City staff recommend Council award the contract for the Project to Sierra Traffic Markings in an amount not to exceed \$200,000; and

WHEREAS, there is no additional fiscal impact as City divisions/departments will use previously approved budgeted amounts to cover associated costs with this contract.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Rocklin as follows:

<u>Section 1.</u> The City Council awards the contract for the City of Rocklin Striping and Marking Maintenance Services 2021/22 Project to Sierra Traffic Markings, Inc. in an amount not to exceed \$200,000 annually.

<u>Section 2.</u> The City Manager is authorized to execute an Agreement with Sierra Traffic Markings Inc. for the Striping and Marking Maintenance Services 2021/22 Project in substantially the form attached hereto as Exhibit "A."

<u>Section 3.</u> The City Manager is authorized to renew the contract with Sierra Traffic Markings Inc. for striping and maintenance services for two (2) additional one-year periods, in an amount not to exceed \$200,000 per year, provided funds are available.
