## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN AWARDING THE CONTRACT FOR THE PROJECT APPROVAL AND ENVIRONMENTAL DOCUMENT (PA&ED) FOR THE ROCKLIN ROAD AND INTERSTATE 80 INTERCHANGE PROJECT TO JACOBS ENGINEERING GROUP INC, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT

WHEREAS, the Rocklin Road and Interstate 80 Interchange Project, also known as the Rocklin Road/Sierra College Corridor Multimodal Enhancements, consists of improving pedestrian and multimodal facilities within the Rocklin Road/I-80 corridor to promote connectivity between Sierra College and the surrounding communities; and

WHEREAS, the first step of this project is to complete a Project Approval and Environmental Document (PA&ED) which must meet all applicable California Environmental Quality Act (CEQA)/National Environmental Policy Act (NEPA) requirements and Laws/regulations; and

WHEREAS, the City issued a Request for Proposals for the PA&ED that was advertised on April 16, 2021, and April 23, 2021, with the submittal date of May 21, 2021; and

WHEREAS, staff received four proposals which were evaluated, and Jacobs Engineering Group, Inc. was determined to present the proposal most advantageous for the City, with a negotiated contract amount not to exceed \$1,800,000; and

WHEREAS, this project funded entirely with South Placer Regional Transportation Authority Funds (SPRTA) (Fund 240) and is included in the FY 2021/22 Budget.

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

<u>Section 1.</u> The City Council of the City of Rocklin awards the contract for the Project Approval and Environmental Document (PA&ED) for the Rocklin Road and Interstate 80 Interchange Project to Jacobs Engineering Group, Inc. in an amount not to exceed \$1,800,000.

<u>Section 2.</u> The City Council of the City of Rocklin approves and authorizes the City Manager to execute an Agreement in substantially the form attached hereto as Exhibit "A" for the PA&ED for the Rocklin Road and Interstate 80 Interchange Project with Jacobs Engineering Group, Inc.
