## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN DECLARING THE EXISTENCE OF AN EMERGENCY PURSUANT TO PUBLIC CONTRACT CODE SECTION 22050, AND ACCEPTING THE REPAIRS TO THE BROKEN STORM DRAIN PIPE NEAR 1800 KENDALL DRIVE IN THE CITY OF ROCKLIN

WHEREAS, the City is generally required by local and state law to competitively bid public works projects which include construction contracts and repairs;

WHEREAS, pursuant to California Public Contract Code section 22050, an exception to the competitive bidding process is permitted if there exists an emergency situation which requires immediate action; and

WHEREAS, in early June 2021, City staff became aware of a sink hole created on the drainage crossing near 1800 Kendall Drive, within the City limits, caused by a broken storm drain pipe; and

WHEREAS, the broken storm drain pipe was in close proximity to the roadway and main water line; and

WHEREAS, failure to immediately repair the storm drain pipe would have resulted in danger to the public health, safety, property, and essential public services; and

WHEREAS, City staff directed Glissman Excavating Inc. to repair the broken storm drain pipe, the repair project is complete, and the fees for such services were approximately \$19,300.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

<u>Section 1</u>. The above referenced recitals are true and correct and incorporated herein by reference.

<u>Section 2.</u> The public interest and necessity demanded the immediate expenditure of public funds to repair the broken storm drain pipe in order to safeguard, prevent, and mitigate the loss or impairment of public health, safety, property, and essential public services. The emergency situation would not have permitted a delay resulting from competitive solicitation for bids and immediate action was necessary to respond to the emergency.

<u>Section 3.</u> The City Manager or her designee was authorized to procure all necessary equipment, services, and supplies for the purpose of remedying the emergency, without giving notice for bids to let contracts, and to expend such funds as he/she may determine are necessary

to accomplish these purposes, subject to an in accordance with Section 22050(b) of the Public Contracts Code.

<u>Section 4.</u> The Council reviewed the completed emergency action at its regular meeting on July 27, 2021, and determined that there is no need to take further action as a result of the emergency.

<u>Section 5</u>. The public work known as the Repair of the Broken Storm Drain Pipe and Sink Hole at or about 1800 Kendall Drive, in the City of Rocklin is accepted.
