RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN APPROVING THE  
FIRST ADDENDUM TO THE 2012 GENERAL PLAN ENVIRONMENTAL IMPACT REPORT (EIR)  
(2021-2029 HOUSING ELEMENT AND 2021 SAFETY ELEMENT UPDATE  
/ GPA2021-0002 & GPA2021-0003)

The City Council of the City of Rocklin does resolve as follows:

Section 1. The City Council of the City of Rocklin hereby finds and determines as follows:

A. The City Council of the City of Rocklin approved and certified an Environmental Impact Report for the 2012 General Plan Update by Resolution No. 2012-170 on October 9, 2012 (State Clearinghouse Number 2008072115).

B. The General Plan is the foundational policy document guiding development for the City of Rocklin. It defines the framework by which the physical, economic, and human resources of the City are to be managed and utilized over time through buildout. The 2012 General Plan Environmental Impact Report (GP EIR) analyzed the environmental effects of development at the program level throughout the City and was created as a self-mitigating document.

C. The California Environmental Quality Act requires the City to analyze the proposed updates to the Housing and Safety Elements under the Public Resources Code Section 21166 and CEQA Guidelines Section 15162 to determine whether further environmental analysis is required.

D. The City has performed the required analysis under Public Resources Code Section 21166 and CEQA Guidelines Sections 15162 and 15164, and based on the analysis and findings contained in the First Addendum to the 2012 General Plan Final Environmental Impact Report attached hereto as Exhibit "A," finds that no subsequent or supplemental environmental impact report is required to be prepared for the updates to the Housing and Safety Elements.

Section 2. The City Council of the City of Rocklin hereby approves Exhibit "A," the First Addendum to the 2012 General Plan Final Environmental Impact Report as the appropriate level of environmental review for the 2021-2029 Housing Element, 2021 Safety Element and associated Safety Element Action Plan Updates and the incorporation of the Addendum into the 2012 General Plan EIR by reference.
