# RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN ACCEPTING THE PUBLIC WORK KNOWN AS THE MEDIAN IMPROVEMENT PROJECT AT THE INTERSECTIONS OF LONETREE BOULEVARD AT SANDHILL DRIVE AND STANFORD RANCH ROAD AT BREEN DRIVE, APPROVING THE NOTICE OF COMPLETION, AND AUTHORIZING THE EXECUTION AND RECORDATION OF THE NOTICE (Central Valley Engineering and Asphalt, Inc.)

WHEREAS, the costs for this Project were included in the Fiscal Year (FY) 2020/21 budget and no additional appropriation was necessary.

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

- Section 1 The attached Notice of Completion relative to that public work known as Median Improvement Project at the Intersections of Lonetree Boulevard at Sandhill Drive and Stanford Ranch Road at Breen Drive (Central Valley Engineering and Asphalt, Inc.), is hereby approved and the public work accepted.


#### **NOTICE OF COMPLETION**
