#### **EXHIBIT B**

#### <u>Financial Interest Categories</u>

#### Category 1

- (a) Interests in real property which is located in whole or in part either (1) within the boundaries of the City of Rocklin, or (2) within the two miles of the boundaries of the City of Rocklin, including any leasehold, beneficial, or ownership interest or option to acquire such interest in real property.
- (b) Investments in, income from, or business positions in business entities or persons which are contractors or subcontractors which are or have been within the previous two-year period engaged in the performance of building construction or design within the City of Rocklin.
- (c) Investments in, income from, or business positions in business entities or persons engaged in the acquisition or disposal of real property within the jurisdiction of the City of Rocklin.

#### Category 2

Investments in, income from, or business positions in business entities or persons which manufacture or sell supplies, books, machinery, or equipment of the type utilized by the department in which the designated employee is employed or which staffs the board or commission of which the official is a member. Investments include interests described in Category 1.

#### Category 3

Investments in, income from, or business positions in business entities or persons which are contractors or subcontractors engaged in the performance of work or services of the type utilized in the department in which the designated employee is employed or which staffs the board or commission of which the official is a member. Investments include the interests described in Category 1.
