RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN APPROVING THE UPDATED FACILITY USER GROUP CATEGORIES, RESERVATION PERIODS, RENTAL FEE AND NON-PROFIT USE POLICY, REPEALING RESOLUTION 2013-81, AND DELEGATING AUTHORITY TO THE DIRECTOR OF PARKS AND RECREATION TO SET FACILITY RENTAL FEES

WHEREAS, on September 8, 2009, the City of Rocklin adopted Resolution 2009-231 establishing the Facility User Group Categories, Reservation Period, Rental Fee Policy for the Rocklin Community Center, Finnish Temperance Hall, and the Rocklin Sunset Center; and

WHEREAS, in order to ensure the policy provided equality for all groups and long-term sustainability for the City, the City Council adopted Resolution 2013-81 which updated the Facility User Group Categories, Reservation Periods, Rental Fee Policy for the Rocklin Community Center, Finnish Temperance Hall, and the Rocklin Sunset Center, which included a lower cost fee structure for non-profit entities; and

WHEREAS, in order to ensure that the Facility User Group Categories, Reservation Periods, Rental Fees and Non-Profit Use Policy is accurate and up to date, staff has reviewed and proposes updates to the policy adopted by Resolution 2013-81; and

WHEREAS, the new Facility User Group Categories, Reservation Periods, Rental Fee and Non-Profit Use Policy includes updated processes and procedures to ensure the policy continues to be beneficial to residents, non-profit groups, the City, and all other facility users; and

WHEREAS, it is requested Council delegate authority to the Director of Parks and Recreation or his/her designee, to set fees for rental of City facilities in accordance with the proposed revised Policy.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Rocklin as follows:

<u>Section 1.</u> The updated Facility User Group Categories, Reservation Periods, Rental Fee and Non-Profit Use Policy attached hereto as Exhibit "A," is approved.

<u>Section 2</u>. Resolution 2013-81 is hereby repealed.

<u>Section 3</u>. The City Manager or his/her designee, is authorized to set fees for rental of City facilities in accordance with the revised Facility User Group Categories, Reservation Periods, Rental Fee and Non-Profit Use Policy.
