PREPARATION OF THE ENVIRONMENTAL IMPACT REPORT, AND APPROVING ADDITIONAL
BUDGET APPROPRIATIONS

WHEREAS, on April 25, 2017, pursuant to Resolution 2017-71, the City of Rocklin entered into a Consultant Services Agreement with De Novo Planning Group for the preparation of an Environmental Impact Report (EIR) for the College Park project in an amount not to exceed \$146,695, and an Agreement for the Payment of Cost of Preparation of the Environmental Impact Report with Evergreen Sierra East, LLC; and

WHEREAS, on August 24, 2021, pursuant to Resolution 2021-146, the City of Rocklin executed a first amendment to the existing contract with De Novo Planning Group to provide additional services for preparation of an Environmental Impact Report for the College Park project, and pursuant to that same resolution the City of Rocklin executed a first amendment to the Agreement between the City of Rocklin and Evergreen Sierra East, LLC requiring the expense associated with the Environmental Impact Report to be covered by the project applicant/developer; and

WHEREAS, additional consultant services for the preparation of an Environmental Impact Report for the College Park project are necessary, and therefore, an amendment to both agreements is necessary; and

WHEREAS the expense associated with amendment the agreements is fully covered by the project applicant/developer.

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

- <u>Section 1</u>. The City Council of the City of Rocklin hereby approves and authorizes the City Manager to execute Amendment No. 2 to the Consultant Services Agreement with De Novo Planning Group for the Preparation of an Environmental Impact Report for the College Park Project in substantially the form attached hereto as Exhibit "1."
- <u>Section 2</u>. The City Council of the City of Rocklin hereby approves and authorizes the City Manager to execute Amendment No. 2 to the Agreement for Payment of Cost of Preparation of an Environmental Impact Report with Sierra Evergreen East, LLC in substantially the form attached hereto as Exhibit "2."

<u>Section 3</u>. The City Manager is authorized to increase the revenue and expenditure budgets in the FY 2021/22 Community Development Department budget in the amount of \$19,140 in the General Fund (100).

Group ("Consultant"), who agree as follows:	

WHEREAS, on April 25, 2017, the City and De Novo Planning Group entered into a Consultant Services Agreement for the preparation of an Environmental Impact Report for the Sierra Villages Project, now the College Park Project ("Agreement"), in an amount not to exceed \$146,695; and

WHEREAS, on August 24, 2021, the City and De Novo Planning Group entered into Amendment No. 1 to the Agreement in an amount not to exceed \$161,085; and

WHEREAS, the City and De Novo Planning Group agree to enter into Amendment No. 2 of the Agreement to include payment and performance of additional services.

AGREEMENT

NOW THEREFORE, the City and De Novo Planning Group hereby agree to amend the Agreement as follows:

- 1. Section 1, "Services", is hereby amended to include the additional services described in Exhibit "A," attached hereto and incorporated herein by reference. Consultant shall provide said services at the time, place and manner as specified in Exhibit A.
- 2. Section 2, "Payment," is hereby amended to include the additional services and associated costs set forth in Exhibit "B," attached hereto and incorporated herein by reference. The total not to exceed amount for the services under the agreement is increased from \$161,085 to \$180,225.

Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is a conflict between this Amendment and the Agreement, the terms of this Amendment will prevail.

EXHIBIT A

Scope of Work

Proposal for Additional Services for College Park (formerly Sierra Villages) Project Environmental Impact Report (EIR)

De Novo Planning Group has received the public comment letters on the Draft EIR requiring a written response. The number of public comment letters requiring written response are approximately double what De Novo Planning Group budgeted in the original scope and therefore De Novo Planning Group is requesting additional funds under Tasks H and I to address this additional effort. A detailed breakdown of the hours needed to accomplish these additional tasks is provided in Exhibit B. The budget request is for \$19,140. The original budget was for \$146,695, which was amended by Amendment No. 1 by \$14,390 to \$161,085, so the new budget request would make the total contract \$180,225.

RECITALS

WHEREAS, on April 25, 2017, the City and Evergreen Sierra East, LLC entered into an Agreement for Payment of Cost of Preparation of an Environmental Impact Report ("Agreement") for the Sierra Villages Project, now known as the College Park Project, in an amount not to exceed \$146,695; and

WHEREAS, on August 24, 2021, the City and Evergreen Sierra East, LLC entered into Amendment No. 1 to the Agreement in an amount not to exceed \$161,085; and

WHEREAS, the City and Evergreen Sierra East, LLC agree to enter into Amendment No. 2 of the Agreement to include payment for additional services.

AGREEMENT

NOW THEREFORE, the City and Evergreen Sierra East, LLC hereby agree to amend the Agreement as follows:

1. Section 4 is hereby amended to increase the total amount Evergreen East, LLC shall pay to City for the preparation of an Environmental Impact Report from \$161,085 to \$180,225. The additional \$19,140 is due and payable at the time of execution of this Amendment.

Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is a conflict between this Amendment and the Agreement, the terms of this Amendment will prevail.
