RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN APPROVING THE CONTRACT FOR SERVICES WITH APS ENVIRONMENTAL INC. FOR THE SOUTH WHITNEY BOULEVARD EMERGENCY PIPE REPAIR AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE CONTRACT

WHEREAS, the City is required by the state and local law to competitively bid public works projects which include construction contracts and repairs unless there exists an emergency situation which requires immediate action; and,

WHEREAS, on December 14, 2022, the City Council of the City of Rocklin was informed of an emergency situation regarding a blocked storm drain lifting the manhole cover and forcing water out of the manhole at South Whitney Boulevard at Lincoln Avenue in the City of Rocklin; and

WHEREAS, it was originally estimated that approximately twenty feet of drain pipe was blocked however, as work has progressed it was discovered that approximately 100 feet of drain pipe has collapsed and must be replaced at an estimated cost of \$150,000; and

WHEREAS, pursuant to the Rocklin Municipal Code, section 3.04.050, a contingency amount of fifteen percent of the contract (\$22,500), is automatically authorized for all public works project contracts awarded by the City Council or the City Manager, as long as adequate funds have been appropriated, bringing the total authorized Project amount to \$172,500; and

WHEREAS, it is imperative that the pipe be replaced without the delay that would be caused by a competitive bidding process, to make sure the local area drains properly (avoiding potential street flooding), ensuring that further system failures are averted, and that nearby utilities are safe; and

WHEREAS, this project will be funded out of the Gas Tax Fund (210), will require a budget appropriation, and may necessitate a budget amendment.

NOW THEREFORE, the City Council of the City of Rocklin does resolve as follows:

1. The above referenced recitals are true and correct and incorporated herein by reference.

2. The public interest and necessity demands the immediate expenditure of public funds to repair the collapsed drain pipe in order to safeguard health and property. The emergency situation would not have permitted a delay resulting from competitive solicitation for bids and immediate action was necessary to respond to the emergency.

3. The City Manager or her designee is authorized to procure all necessary equipment, services, and supplies for the purpose of remedying the emergency, without giving notice for bids to let contracts, and to expend such funds as she may determine are necessary to accomplish these purposes, subject to an in accordance with Section 22050(b) of the Public Contract Code.

4. The City Council approves the Contract for Services with ALS Environmental Services Inc. for the emergency work, and authorizes the City Manager to execute the agreement in substantially the form attached hereto as Exhibit "A".
