## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN ACCEPTING THE PUBLIC WORK KNOWN AS THE MISSION HILLS PHASE 3 ROAD RECONSTRUCTION PROJECT, APPROVING THE NOTICE OF COMPLETION THEREOF, AND AUTHORIZING AND DIRECTING THE EXECUTION AND RECORDATION OF SAID NOTICE ON BEHALF OF THE CITY

(McGuire and Hester)

WHEREAS, on February 22, 2022, the City Council of the City of Rocklin adopted Resolution 2022-46 awarding the contract for the Mission Hills Phase 3 Road Reconstruction Project to McGuire and Hester in an amount not to exceed \$846,482; and

WHEREAS, this project consisted of removing and replacing existing asphalt concrete surfacing and underlying base material on Mountain View Dr., Roble Way, Verano Way, Hillside Dr. and Argonaut Ave.; and

WHEREAS, the City entered into an agreement with South Placer Municipal Utility District for a reimbursement amount not to exceed \$32,800 for repair/replace/upgrade portions of their infrastructure during construction of the project; and

WHEREAS, the City entered into an agreement with Placer Water County Agency for a reimbursement amount not to exceed \$16,400 which was later increased to \$17,600 for repair/replace/upgrade portions of their infrastructure during construction of the project; and

WHEREAS, the Rocklin Municipal Code section 3.04.050 authorized a contingency amount of fifteen percent of the contract (\$126,900), for a total authorized project cost of \$973,382; and

WHEREAS, the project was completed on June 13, 2022, at a total cost of \$848,752 (rounded), and the City's portion of the total project was \$798,352 (rounded) which is under the approved project amount of \$973,200 (rounded); and

WHEREAS, the costs for this project were included in the Fiscal Year (FY) 2021/22 budget and an appropriation in the amount of \$283,000 was previously approved and may necessitate a budget amendment.

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

- <u>Section 1</u> The attached Notice of Completion relative to the public work known as Mission Hills Phase 3 Road Reconstruction Project (McGuire and Hester), is hereby approved and the public work accepted.
- <u>Section 2</u>. The Director of Public Services is authorized and directed to execute said Notice on behalf of the City of Rocklin.
- Section 3. The City Clerk is authorized and directed to record said Notice in the Office of the Placer County Recorder when fully executed and notarized and within ten (10) days of Council approval.
