RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN  
ACCEPTING THE PUBLIC WORK KNOWN AS THE SIERRA COLLEGE BOULEVARD HMA OVERLAY  
PROJECT, APPROVING THE NOTICE OF COMPLETION THEREOF, AND AUTHORIZING AND  
DIRECTING THE EXECUTION AND RECORDATION OF SAID NOTICE ON BEHALF OF THE CITY  
(George Reed, Inc.)

WHEREAS, the City Council of the City of Rocklin approved Resolution 2021-167 awarding the bid for the Sierra College Boulevard HMA Overlay Project to George Reed, Inc.; and

WHEREAS, This project consisted of paving (overlay) the roadway on Sierra College Boulevard (SCB) from Del Mar Avenue to the Placer County Line; and

WHEREAS, Rocklin Municipal Code section 3.04.050 authorized a contingency amount of fifteen percent of the contract (\$75,238) and additional budget appropriations totaling \$58,022 were approved by the City Council of the City of Rocklin for a total authorized project cost of \$634,846; and

WHEREAS, the project was completed on August 12, 2022 at a total cost of \$630,973 (rounded).

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

Section 1 The attached Notice of Completion relative to the public work known as Sierra College Boulevard HMA Overlay Project (George Reed, Inc.), is hereby approved and the public work accepted.

Section 2. The Director of Public Services is authorized and directed to execute said Notice on behalf of the City of Rocklin.

Section 3. The City Clerk is authorized and directed to record said Notice in the Office of the Placer County Recorder when fully executed and notarized and within ten (10) days of Council approval.
