RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN
DECLARING THE RESULTS OF THE CONSOLIDATED SPECIAL ELECTION HELD IN THE CITY OF
ROCKLIN ON NOVEMBER 8, 2022, FOR ONE COUNCILMEMBER FOR A SHORT (TWO-YEAR) TERM

WHEREAS, a Consolidated Special Election was held and conducted in the City of Rocklin, County of Placer, State of California, on Tuesday, the 8th day of November, 2022, as directed by City Council; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 2022-158 adopted on July 5, 2022, the Placer County's Election Office canvassed the returns of the election and has certified the results are received, as set forth below.

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

Section 1. The whole number of votes (ballots) cast in the City for the Member of City Council – Short Term was 25,819.

Section 2. The names of persons voted for at the election for Member of the City Council – Short Term are as follows:

David Bass
Matthew Oliver

Section 3. In accordance with California Elections Code section 10262, the City Clerk has certified the results of the election to the City Council. The number of votes given at each precinct and the number of votes given to each of the persons above named for the office of Member of City Council – Short Term are as follows:

David Bass	13,109	50.77%
Matthew Oliver	12,710	49.23%

Section 4. The City Council does declare and determine that David Bass is elected as a Member of the City Council for the short term of two years.

Section 5. The City Clerk shall enter on the records of the City Council of the City of Rocklin, a statement of the results of the election showing: (1) the whole number of votes (ballots) cast in the City; (2) the names of the person voted for Member of the City Council (short term); and (3) the total number of votes given to each person.

Section 6. The City Clerk shall immediately make and deliver to the person so elected a Certificate of Election signed by the City Clerk and authenticated; the City Clerk shall also administer to the person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. The person so elected shall then be inducted into the respective office to which they have been elected.
