STANDARDS OF DECORUM

Any person who disrupts the meeting of the Art Task Force may be barred by the presiding member from further audience before the Art Task Force during that meeting, unless permission to continue be granted by majority vote of the Art Task Force.

All remarks shall be addressed to the Art Task Force as a body and not to any member thereof, or to staff, or to the public. No person, other than a member of the Art Task Force, and the person having the floor, shall be permitted to enter into any discussion without the permission of the presiding member. For items not on the agenda, and for non-hearing items on the agenda the person addressing the Art Task Force shall be limited to five (5) minutes, unless the time is adjusted by the presiding member.

Whenever any group of persons wishes to address the Art Task Force on the same subject matter, it shall be proper for the presiding member to request that a spokesman be chosen by the group to address the Art Task Force and, in case additional matters are to be presented at the time by any member of the group, to limit the number of persons so addressing the Art Task Force, so as to avoid unnecessary repetition.

Art Task Force Comment:

- Commissioner Armstrong welcomed Members Neil Bullock and Diana Ruhkala Bell to the Art Task Force.
- Member Bullock introduced himself.
- Member Ruhkala Bell introduced herself.
- Members Olson and Swerdlow, as well as Commissioner Stockton welcomed Bullock and Ruhkala Bell.

6. Public Art Update

Kevin Huntzinger presented.

CITY HALL MURAL PLAQUE

Art Task Force Comment:

- Commissioner Stockton and Member Olson questioned if there will be one plaque versus two as previously discussed. Stockton noted that she is not opposed to one sign as long as it contains the story and recognitions.
- Member Swerdlow is in favor of one sign as long as it contains the story. Swerdlow questioned if it is possible to place a traditional plaque on the wall next to the mural or closer to it.
- Member Bullock questioned the amount of traffic that passes the proposed sign location(s).
- Member Ruhkala Bell inquired about the material the storyboard sign would be made from.
- Member Swerdlow discussed there being sign examples throughout Rocklin, including one at a Ruhkala Park. Swerdlow commented on the example she provided to staff from a mural in Boise.
- Member Ruhkala Bell suggested painting something next to the mural in lieu of a plaque.
- Mayor Gayaldo questioned the projected lifetime of the City Hall Mural. Gayaldo is in favor of a storyboard.
- Commissioner Stockton suggested that Member Swerdlow work with staff to create the story for the sign, to include the original picture of the miners.
- Member Bullock questioned if the sign will be the only element to help interpret the artwork.

• Member Swerdlow commented on the website being a doorway into much more information.

BIG GUN SCULPTURE

Art Task Force Comment:

- Commissioner Stockton questioned if there is potential for the Big Gun Sculpture to be an RDA project.
- Mayor Gayaldo expressed concerns about possible conflicts, since the areas are undeveloped.
- Member Swerdlow discussed developing a plan using City property and applying for grants.
- Member Swerdlow and Mayor Gayaldo explained to Members Bullock and Ruhkala Bell the history of the project idea.
- The group discussed potential locations for the sculpture, as well as guidelines.
- Commissioner Armstrong requested a copy of the slide designating RDA vs. City property be sent out to the group.
- Commissioner Stockton asked that the pictures of the potential sculpture materials be sent out to the group as well.

- Member Swerdlow noted that she will be assisting Ritu Atwal in repairing the "Off the Rails" mining cart that was vandalized.
- Member Swerdlow will reach out to the artists to check their availability to be recognized in a ceremony.

7. Tri City Little League Mural

Kevin Huntzinger presented.

Commission Comment:

- Commissioner Stockton questioned if Tri City Little League (TCLL) is still interested in being the lead on the mural project.
- Commissioner Stockton asked staff to explain the reasoning behind the picture selected for the mural.
- Member Swerdlow noted she is comfortable with the mural concept (child with umpires). Swerdlow discussed branding and advertising versus art.
- Commissioner Armstrong explained that TCLL was notified they may not put their name and logo on City property.
- Commissioner Stockton discussed removing the large "TC" and having the picture wrap around with a notation at the bottom "sponsored by Tri City Little League". Mayor Gayaldo was in agreement with this idea.
- Member Swerdlow requested that another mural concept be provided without the large "TC".
- Member Bullock questioned if there are City guidelines that need to be followed regarding branding or advertising on City property.
- Member Swerdlow asked staff to let TCLL know that Mural Concept #2 looks too much like an advertisement and not like an artistic mural representing the sport.
